

EXECUTIVE ORDER D-825-3

Relating to Exemptions Under Section 27156 Of the California Vehicle Code

Automotorsport Inc. AKA AMS Performance
AMS Performance VW/Audi 2.0T TSI EA888 Front Mount Intercooler

Pursuant to the authority vested in the California Air Resources Board by Section 27156 of the California Vehicle Code, and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-19-095;

IT IS ORDERED AND RESOLVED: That installation of the AMS Performance VW/Audi 2.0T TSI EA888 Front Mount Intercooler manufactured by Automotorsports Inc. AKA AMS Performance, 1760 Metoyer Court, West Chicago, Illinois 60185 has been found not to reduce the effectiveness of the applicable vehicle pollution control systems and, therefore, is exempt from the prohibitions of Section 27156 of the California Vehicle Code, and for the 2015 to 2021 model year Audi and Volkswagen vehicles listed in Exhibit A of this document.

The AMS Performance VW/Audi 2.0T TSI EA888 Front Mount Intercooler is a direct replacement of the stock intercooler unit and consists of the following main components: the intercooler unit, tubing, couplers, mounting brackets, clamps, and all the necessary hardware to complete the installation. Also, it retains the stock air filter housing and the air filter element. The AMS Performance VW/Audi 2.0T TSI EA888 Front Mount Intercooler does not need engine calibration, and therefore, the vehicle maintains the stock ECU calibration.

This Executive Order is valid, provided that the installation instructions for the AMS Performance VW/Audi 2.0T TSI EA888 Front Mount Intercooler will not recommend tuning the vehicle to specifications different from those of the vehicle manufacturer.

Changes made to the design or operating conditions of the AMS Performance VW/Audi 2.0T TSI EA888 Front Mount Intercooler, as exempted by the California Air Resources Board, that adversely affect the performance of the vehicle's emission control system shall invalidate this Executive Order.

This Executive Order shall not apply to any AMS Performance VW/Audi 2.0T TSI EA888 Front Mount Intercooler advertised, offered for sale, sold with, or installed on a new motor vehicle prior to or concurrent with transfer to an ultimate purchaser.

Marketing of the AMS Performance VW/Audi 2.0T TSI EA888 Front Mount Intercooler using any identification other than those shown in this Executive Order or marketing of the AMS Performance VW/Audi 2.0T TSI EA888 Front Mount Intercooler for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the California Air Resources Board.

This Executive Order does not constitute any opinion as to the effect the use of the AMS Performance VW/Audi 2.0T TSI EA888 Front Mount Intercooler may have on any warranty either expressed or implied by the manufacturer.

Exemption of the AMS Performance VW/Audi 2.0T TSI EA888 Front Mount Intercooler shall not be construed as an exemption to sell, offer for sale, or advertise any component of the assembly as individual devices.

This Executive Order is granted based on the submitted vehicle test result in the modified configuration submitted by Automotosports Inc. AKA AMS Performance, including emissions test data.

The California Air Resources Board reserves the right in the future to review this Executive Order and the exemption provided herein to assure that the exempted add-on or modified part continues to meet the standards and procedures of Title 13, California Code of Regulations, Section 2222, et seq.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY THE CALIFORNIA AIR RESOURCES BOARD OF ANY CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF THE AUTOMOTORSPORTS INC. AMS PERFORMANCE VW/AUDI 2.0T TSI EA888 FRONT MOUNT INTERCOOLER.

No claim of any kind, such as "Approved by the California Air Resources Board," may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request, and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
